Dealer badges will be issued only to those listed and any last-minute changes will be considered only after the official opening of the Convention. Only those with Dealer badges and Assistant badges are allowed behind a Bourse table.

Michigan State Numismatic Society reserves the right to refuse a table to anyone or company for any reason without liability, also we reserve the right to deny a dealer's assistant credentials to be behind the table. **We also have the right to assign table locations without recourse.**
