 - A) ICTA Annual Membership Continuing Resolution to Renew Annually

Irick

- a. MSNS has maintained a basic membership in ICTA for a number of years.
- b. Discussion indicated that the consensus of the Board is that the ICTA renewal will continue to be approved annually to ensure visibility of the renewal cost and benefits of ICTA membership.
- Motion by Malhalab, seconded by Chirco, that the annual ICTA Basic membership dues be paid by the Treasurer every year contingent that the ICTA membership price does not increase.
- d. Motion by Sirna, seconded by Klunzinger to table the above motion
- B) Authorized Check Signer One Signature Authority Increase from \$500 to \$1,000 Irick
 - a. Currently, the MSNS Policy manual authorizes the Treasurer, or in the Treasurer's absence, other authorized signers, to provide a single signature on checks up to and including \$500.
 - b. The \$500 control point is now triggered one to several times per month resulting in extra effort and cost to mail the physical check to a second signer and then have the check mailed on.

- c. Depending on the travel schedule, both planned or unplanned, of the second signers, there can be second signature delay. This causes a risk of a check not being received on time with the potential of late fees being assessed on our account.
- d. Motion by Sirna seconded by Marzilli to authorize the Treasurer, or in the Treasurer's absence, other authorized signers to provide a single signature on checks up to and including \$1000. passed unanimously
- C) Ray Dillard Elongated Coin Proposal

Bobrofsky

- a. Gifts of elongated coins are a long established tradition during MSNS Conventions.
- b. Ray Dillard, advising advanced age of 92 advised that starting with the Spring 2017 Convention he will attend Conventions when possible but not throughout the entire Convention.
- c. He is willing to continue to produce and deliver the same quantity of elongated coins to future Conventions.
- d. Motion by Bobrofsky seconded by Sirna to approve the continuation of the elongated program passed unanimously
